Legislative Update on MDCH Budget

**Senate Appropriation Committee Accepts Budget Proposal
House Appropriations Subcommittee Hearings Continue**

Coalition members and staff continue to advocate for the reinstatement of Medicaid adult dental. Yesterday, the full Senate Appropriations Committee accepted its Subcommittee's proposal on the Michigan Department of Community Health budget which fully reinstates adult dental. The estimated cost would be \$5.25 million General Fund, which would bring in \$14.3 million in federal match. As this is only the beginning of the budget process, the Coalition will continue its advocacy efforts.

Earlier this week, the House Appropriations Subcommittee on Community Health held its first hearing on the budget. Board Chair Patti Ulrich testified on behalf of the Coalition. The Subcommittee's next public hearing is scheduled March 22 (10 a.m. to 12 p.m.) at Grace-Sinai Hospital located at 6071 W. Outer Drive in Detroit. Member Janice Harbin-Joseph, DDS of Detroit Department of Health and Wellness Promotion and Karlene Ketola, executive director are set to testify. Marine City Resumes Fluoridation

Several local dental professionals, residents and a representative from the health department showed their support for water fluoridation at the Feb. 18 Marine City Commission meeting. St. Clair County Health Department Medical Director Dr. Annette Mercatante named fluoride as "one of the most important health components in the community."

Mercatante said during her extensive research, she found "no real scientific controversy" with fluoride administered in the proper quantities. Resident Kim Turner said she was opposed to fluoridating city water, pointing out the U.S. Food and Drug Administration's warning on toothpaste to keep it out of reach of children. Turner said she has avoided fluoride and has had no problems with tooth decay.

Mayor Bob Lepley presented a list of more than 100 national and international organizations that recognize fluoride as a health benefit in preventing tooth decay. Lepley said his research led him to take a pro-fluoride position. He made a motion to take steps aimed at getting another fluoridation unit for the water plant to resume the practice of treating city water.

Commissioner Jim Turner asked that the issue be tabled until the city could get more feedback from residents, but did not receive support. The vote was 5-1 for fluoridation, with Turner the dissenting vote. Finding the money for new equipment is the next challenge before city officials. According to Tetra Tech, the city's water plant operators, the estimated cost is \$20,000. Marine City Manager John Gabor recommended the city apply for funding through a grant from the Michigan Department of Community Health.

"Replacement costs of this equipment are unfunded at this point and would require a subsidy for the general fund," stated Gabor in his report. "If successful in obtaining the grant, the equipment would have to be installed between June 1, 2010 and Sept. 30, 2010."

Business Leaders Issues Benchmarking Report Group Assesses Michigan's Economic Competitiveness

Business Leaders for Michigan released a comprehensive benchmarking report that assessed Michigan's economic competitiveness on more than 100 factors important to job creation. The report is based on an extensive fact-based analysis of Michigan's performance compared to peer regions using both input and output factors over a nine-year period.

The Business Leaders for Michigan report reached the following conclusions:

1. Michigan's economic performance has eroded significantly, with both GDP growth over the past 18 months and unemployment last among the 50 states.
2. The state's business costs are uncompetitive, with the cost of doing business 4% above the national average - driven by high corporate taxes and total labor costs.
3. Michigan is delivering average to above average results from innovation and entrepreneurship, but additional work is needed to become a leading state.
4. The state's quality of life has strong fundamentals, but has a very poor perception.

Latest Kaiser CHIP Tip

Examining Improved Children's Oral Health Benefits

A new [issue brief](#) from the Kaiser Foundation's Commission on Medicaid and the Uninsured (KCMU) examines a new requirement under the Children's Health Insurance Program Reauthorization Act of 2009 (CHIPRA) that state CHIP programs cover comprehensive dental benefits. CHIPRA also allows states with separate CHIP programs to offer a dental-only plan for children who have other health insurance but lack adequate dental benefits. Other oral health improvements in the law include education for new parents, better access to benefit and provider information and enhanced reporting on the quality of dental health services in Medicaid and CHIP. The issue brief is the sixth in a series of implementation briefs called "CHIP Tips," which examines new opportunities for covering children following the CHIP reauthorization. The series, which explores a range of topics, is jointly produced by KCMU and the Center for Children and Families at the Georgetown University Health Policy Institute.
