Throughout the summer of 2009, I served as a volunteer within the local public health community. During this time I was blessed with countless opportunities to serve, explore, learn and really begin to determine where I see myself in the dental field.

When Medicaid dental coverage for adults was cut on July 1, it rocked public health clinics throughout the state including Hackley Community Care Center and Muskegon Family Care, the two clinics in Muskegon where I spent my summer as a volunteer. Responding to the anticipated cuts and to take action of some kind, I traveled to Lansing in July to participate in Oral Health Legislative Action Day on Capitol Hill. Study to Determine True Cost of Oral Cancer

University Partners with Delta Dental and Thomson Reuters

The University of Illinois at Chicago College of Dentistry and Delta Dental of Michigan, Delta Dental of Wisconsin, and Thomson Reuters are working together to determine the true cost-burden of oral cancer. The costs of oral cancer, Dr. Joel Epstein, professor of oral medicine and diagnostic sciences said, include the direct cost of care, including medical, pharmacy and dental costs, and ongoing costs due to complications of therapy and potential disability.

Indirect costs include absenteeism and decreased worker productivity that come along with disabling side effects of treatment, said Dr. Jed Jacobson, chief science officer and senior vice president of Delta Dental of Michigan.

Most oral cancers require costly and disfiguring medical intervention. The survival rate is 80 percent to 90 percent if caught in its early stages, Epstein said. The number decreases to 25 percent to 35 percent if detected in the late stages.
